YOU MUST NOTIFY US WITHIN SEVEN (7) DAYS FROM TODAY, _____, THAT YOU HAVE MADE AN APPOINTMENT WITH A CONSUMER CREDIT COUNSELING AGENCY, AND WITHIN 60 DAYS FROM TODAY, _____, THAT YOU HAVE COMPLETED THE CONSUMER CREDIT COUNSELING. WE MAY VERIFY THIS INFORMATION WITH THE AGENCY. IF YOU FAIL TO PROVIDE THE 7-DAY OR 60-DAY NOTICE, OR IF YOU HAVE NOT MADE THE APPOINTMENT OR COMPLETED THE COUNSELING WITHIN THE TIME REQUIRED, WE MAY DEPOSIT OR PRESENT YOUR CHECK FOR PAYMENT AND PURSUE ALL LEGALLY AVAILABLE CIVIL MEANS TO ENFORCE THE DEBT.

Pursuant to Florida Statutes 560.404(22)(c), when you complete an approved payment plan, your Provider must pay one half of the drawer's fee for the deferred presentment transaction to the consumer credit counseling agency you use.
